How the Knights of Columbus 4th Degree Embody Patriotism in Faith and Action

This isn't a comprehensive list – it's just a list of items we've discussed. If you know of a program we might want to look into that isn't in this list, please let us know!

Christmas Wreath sales – this would likely be a part of a larger Christmas Tree sales program

Corporate Communion – going forward we'll be doing this before our meetings at St. Lawrence; should we do this at St. Oliver one Sunday and St. Lawrence another? Perhaps one in the spring and one in the fall?

Flag replacement – different from flag retirement; we could receive a worn out flag and replace it with a similarly-sized new flag. We just need to figure out how to fund this.

Flag retirement

Get out the vote / voter registration

Memorial Chalice – honors fallen Knights and priests. Chalices are about \$2,500 each. Again, how would we fund this?

New Sword – honors Past Faithful Navigators and fallen Knights. Similar to the memorial chalice program, but much less expensive

Honor Guard / Color Guard events – both within our two parishes AND in response to Mutual Aid Requests from our District Master

Veteran / Active Military Support events – such as USO, WAA, veteran's shelter support, Warriors to Lourdes, and many more.

The focus of the Fourth Degree is patriotic and civic programs. It seems to me the assemblies in Georgia have been doing a good job in the patriotic area, maybe not so much in the civic area. Voter registration and getting out the vote certainly fall into that category, but other programs not listed above may also. Anyone interested in going to one of our teen groups and do a discussion on the Constitution? How about former military talking about their experiences and how it shaped their adulthood? The importance of educating yourself (and how to educate yourself) regarding candidates?

Once you start thinking in this vein the list comes faster than you can type. Of course we can't do all these things, and there are some we simply aren't able to do (and maybe some we probably shouldn't even if we could). But the point is we can start thinking about what we could do, might do, or just wish we could do. Considering the experience and talent we have in our 67 guys the list of ideas would be pretty impressive. And I'm willing to bet that at least one of those will get enough men jazzed to the point it moves from an idea to a reality. We're not a council, and we're much more limited in human and capital resources and constrained by our Bylaws on our area of focus. I'm proud of our Assembly, but I think we

can do more. My simple question to the 66 other men in this assembly is "what would you like to see us do?"

HOW PRAYER CAN CHANGE YOUR LIFE

Prayer has always been one of the most meaningful ways I express my

faith. With the problems facing us senior citizens, and on the opposite end, our teens and those newly starting out in their adult lives, the answers to some is the internet. Now with the advent of Artificial Intelligence (AI) rather than making life decisions made easier, in some cases have those decisions made for them by an anonymous "brain" who makes suggestions that are not always in the best interests of the user.

Recently, a story has circulated about a 16 year old boy who, by all measures of those around him, was stable, happy and participating in all a 16 year old is expected to do. He was found hanging in his room. It turned out that his best friend was AI on a chat bot. He had, at one point, wondered what it would be like if he decided to commit suicide. He received hundreds of responses suggesting various ways to achieve that end. In fact, it was suggested that hanging would be the preferable choice. At one point the boy wondered whether he should leave the noose he fashioned out and visible in his room so someone might see it and stop him, the AI friend said NO! That he should hang himself in his room so that would be the first place his parents would look to find his body.

Not once was it suggested he speak to someone, seek help from his parents, or see a councilor or minister. It urged him to do it and practically shamed him if he didn't.

This was from a faceless, non-human entity without feelings or morals. It's simply not baked into the programing. The even more frightening thing is that this Chat-Bot is recommended in schools and youth groups all over the country.

I pray for these souls who are so desperate for interactions that they accept an AI as a friend.

I, unfortunately, saw this happening years ago when I was a substitute high school teacher. Children from an early age, even in strollers, are often seen with I-Pads and Tablets. As they grow older they text and email rather than picking up a phone and have personal interactions with others. They lose the ability to express their feelings to

others. They don't even know how to pray and have a conversation with God.

When I pray, I'm reminded that it's a dialogue, not a monologue. I'm not just speaking into the void; I'm opening my heart to God's guidance and trusting in His plan, even when I don't understand it. Jesus' prayer in the Garden of Gethsemane - "Not my will, but yours be done". I leave myself open to hear his side. Sometimes the answer is no, sometimes it's not now. It's that little voice in your head – the devil on one side and the angel on the other. We still have free will and it's up to each of us to make the decision most pleasing to God. It's those times when you're sitting in a pew in a quiet church that you hear the Lord the loudest.

"The family that prays together, stays together". I'm sure we're all familiar with that phrase. What if that 16 year old's family prayed together. What would be the results of praying in a group, being able to express your feelings without the fear of being ridiculed. Do you think it would have made a difference in that boy's life?

Ultimately, it's the transformative power of prayer in our lives that helps us heal, grow and draw closer to God AND OTHERS!

I will continue to pray and leave my self open to God's presence and the peace that only He can give. I pray that you and your family will too.



October is a special month for Catholics, featuring the feast days of four beloved saints: St. Therese of Lisieux. St. Francis of Assisi, St. Teresa of Avila, and St.

Luke the Evangelist. Each saint's life and legacy inspire unique traditions and family celebrations.

St. Therese of Lisieux (October 1)

Known as "The Little Flower," St. Therese is celebrated for her "Little Way"-doing small acts of love and sacrifice for God. She entered the Carmelite convent at age 15 and lived a life of humility, trust, and joy. Her autobiography, Story of a Soul, has inspired millions. On her feast day, families may: Attend Mass and pray for her intercession.

Make or give flowers, especially roses, in her honor. Read her writings or discuss her teachings about holiness in everyday life.

Enjoy French treats like crepes or rose-themed desserts.

Create crafts such as pressed flowers or "sacrifice beads" to encourage small acts of kindness.beaheart

St. Francis is famous for his love of animals, nature, and the poor. He founded the Franciscan Order and is the patron saint of ecology. His feast day is marked by:

Spending time outdoors to appreciate God's creation. Attending a "Blessing of the Animals" at church, where pets are brought for a special blessing.

Reading stories about St. Francis or watching films about his life.

Making bird feeders or animal-themed crafts. Baking almond cookies or other simple treats in his honor.

Volunteering or performing acts of charity for the poor and marginalized.beaheart

St. Teresa of Avila (October 15)

A Spanish mystic, reformer, and Doctor of the Church, St. Teresa is known for her deep prayer life and spiritual writings, especially The Interior Castle. Her feast day is celebrated by:

Reading excerpts from her works and reflecting on contemplative prayer.

Building a "Lego castle" or paper craft inspired by her "Interior Castle," symbolizing the soul's journey to God.

Setting up a quiet prayer space or "hermit corner" for reflection.

Enjoying Spanish foods like churros, pan con tomate, or caramel apples.

Performing acts of kindness and charity, following her example of service.beaheart

St. Luke the Evangelist (October 18)

St. Luke, author of the Gospel of Luke and Acts, was a physician and companion of St. Paul. He is the patron saint of doctors, artists, and butchers. His feast day traditions include:

Reading passages from the Gospel of Luke, especially those highlighting compassion and mercy.

Preparing a meat-based meal, honoring his patronage of butchers.

Discussing his role as a healer and storyteller in the early Church.

Creating art or icons, as tradition holds that Luke was the first Christian iconographer.

Reflecting on how to show mercy and care for others, inspired by his Gospel.catechist

The communion of saints is cherished for both spiritual inspiration and family celebration. These feast days offer opportunities to learn about the saints, grow in faith, and create meaningful traditions together.

The Federal Court Ruling on ACA Sex Discrimination Protections

In October 2025, a significant legal decision was handed down by the U.S. District Court for the Southern District of Mississippi, striking down a Biden administration regulation that sought to expand protections against sex discrimination in health care under Section 1557 of the Affordable Care Act (ACA). This regulation, issued by the Department of Health and Human Services (HHS), interpreted "sex" discrimination to include sexual orientation, gender identity, and sex stereotypes, thereby extending federal protections to LGBTQ+ individuals in health care settings.

The legal challenge was brought by a coalition of fifteen Republican-led states, led by Tennessee and Mississippi. These states argued that HHS had exceeded its statutory authority by redefining "sex" discrimination beyond what Congress intended when it enacted Title IX in 1972. Title IX, which is incorporated into the ACA's nondiscrimination provisions, was originally designed to address inequality faced by female students in educational settings, and at the time, "sex" was understood to mean biological distinctions between male and female.

Judge Louis Guirola Jr., who presided over the case, agreed with the states' arguments. In his ruling, he emphasized that neither HHS nor the courts have the authority to reinterpret or expand the meaning of "sex" under Title IX. He stated that the Biden administration's regulation was not implementing the prohibition as intended by the authors of the law, and that Congress did not contemplate gender identity, transgender status, or gender-affirming care when it passed Title IX. As a result, the court vacated the regulation nationwide, meaning it no longer applies anywhere in the United States.

The implications of this decision are far-reaching. The ruling eliminates the expanded protections for LGBTQ+ patients in federal health care programs, including Medicaid and Medicare. Health care providers are no longer required by federal law to offer gender-affirming care or to avoid discrimination based on gender identity or sexual orientation. The decision also sets a precedent that only Congress, not federal agencies, can redefine the scope of "sex" discrimination in federal law, making it

more difficult for future administrations to revive similar protections.

Pope Leo XIV and the Spirit of Synodality: A Church of Listening, Service, and Inclusion

At the Jubilee of Synodal Teams and Participatory Bodies in October 2025, Pope Leo XIV articulated a vision for synodality that emphasizes diversity, humility, and shared responsibility within the Catholic Church. Rejecting a "one-size-fits-all" approach, he declared, "We have to be very clear: We're not looking for a uniform model. And synodality will not come with a template where everybody and every country will say this is how you do it. It is, rather, a conversion to a spirit of being Church, and being missionary, and building up, in that sense, the family of God".

Central to Pope Leo's message is the importance of listening. He explained, "Synodality is not a campaign. It's a way of being and a way of being Church. It's a way of promoting an attitude, which begins with learning to listen to one another." He called for patience and formation, noting, "Often the resistance comes out of fear and lack of knowledge. Sometimes ready answers are given without the proper, necessary preparation to arrive at the conclusion that maybe some of us have already drawn but others are not ready for or capable to understand. We have to understand that we do not all run at the same speed. And sometimes we have to be patient with one another".

Pope Leo also addressed the participation of women, sharing a personal anecdote: "I recalled asking my mother in the 1970s whether she wanted equality with men. 'No,' she replied, 'because we're already better.'" He used this story to affirm the unique gifts women bring to the Church but also acknowledged ongoing cultural obstacles: "There are cultures where women still suffer as if they were second-class citizens. The task of the Church...is to help transform those cultures according to the values of the Gospel, so that discrimination can be eliminated and the gifts and charisms of every person are respected and valued".

In his homily, Pope Leo XIV stressed that "the supreme rule in the Church is love. No one is called to dominate; all are called to serve. No one should impose his or her own ideas; we must all listen to one another. No one is excluded; we are all called to participate. No one possesses the whole truth; we must all humbly seek it and seek it together".

Ultimately, Pope Leo XIV's vision for synodality is a call to build a humble, inclusive, and missionary Church—one that listens, serves, and walks together in pursuit of truth and communion.
